

# How to identify the wireless LAN compliant countries or regions for FlashAir™ W-04 (for ASIA sales)


FlashAir™ W-04 has three (3) types. Type1, Type2, and Type3 are different in the wireless LAN compliant countries/regions as listed below.

Use in unlisted countries/regions may violate local ordinances.


The listed countries or regions may increase or decrease without notice.

\*CMIIT ID is an authorization number assigned by the China Ministry of Industry and Information Technology to identify wireless-LAN compliant products in China.


